No business relations shall be initiated, including the opening of a current account, as well as the acceptance and / or transfer of any funds / transactions for individuals / legal entities residing or having citizenship in North Korea, as well as those whose authorized representatives have residence / citizenship in North Korea.

The Bank acts in accordance with national and international laws and regulations regarding restrictions / sanctions (commercial, financial, fund transfer) / embargoes against certain countries / entities / individuals / economic sectors. Therefore, in situations where the transactions involve countries on which restrictions / sanctions (commercial, financial, fund transfer) / embargoes have been imposed, the transactions may be carried out after providing the documents / information showing both the country of origin of the goods and the name of the producer of the goods (certificate of origin issued by the competent authority of the country of the producer of the goods or an equivalent document certifying both the country of the producer and the name of the producer of the goods), in addition to those from which the purpose and nature of the transaction arise invoice / invoices, covering the value of the transaction, contract - when it exists, import / export custom documents).

Thus, in accordance with the general terms and conditions, the bank may request additional information / documents to clarify over the purpose and nature of customer's transactions.
