- Ahead of the FOMC's two-day meeting, trading remained optimistic, with all advanced key benchmarks but the Nikkei achieving gains.
- The price of gold fell further; the EUR/USD was oscillating in a narrow bracket, edging higher.

The Fed's monetary policy meeting has not been so eagerly awaited since last summer when the preparations for launching the QE3 were under way. Market players expect the current meeting to give a hint at any changes to QE3, thus the waiting for the Federal Open Market Committee's decision steals the limelight from any other data release or event. On Monday, investors were preparing in bright mood; practically all advanced market stock indices made gains, and this morning Asia's markets followed suit (except for Nikkei225).

In corporate news, Philips surged almost 3% as Deutsche Bank had revised its hold recommendation to buy.

The Brent crude's price inched higher, while gold sank again. Ahead of the Fed's decision, the EUR/USD was trading in a narrow bracket, creeping higher.

After the negative reading in May, the New York Fed's manufacturing index jumped higher. The gauge for the state of New York may be not as important as the indices to be released later this week for the whole of the USA but, in addition to the variety of other statistics, it confirms that the US economy is advancing.

A number of important data releases are in the pipeline but, given the Fed's forthcoming meeting, they are unlikely to trigger strong market reaction. All the more so because neither consumer price indices nor US real estate data are likely to change the current picture.
