Summary

- BVB indexes were down yesterday on a relatively high turnover (EUR 13.5 mn) out of which 75% made by 2 deals with SIF Banat Crisana; BVB indexes opened lower today, as markets wait for Fed's guidance
- The leu and its peers strengthened against the euro yesterday; EUR/RON is currently trading around 4.46
- The Treasury successfully sold RON 1 bn in 12M T-bills at 3.88%, 27 bps lower than the previous similar auction in the beginning of August; healthy demand with bid to cover at 3.8X.

BVB indexes slid yesterday on a relatively high liquidity turnover, of EUR 13.5 mn out of which 75% represented 2 deals with SIF Banat Crisana. On the regular market, the company lost 5.1%, closing at 1.1 RON/share and it was among top 5 losers by price. However the deals were made at 1.32 RON/share, which means an advance of 13.9% compared to Friday's closing price. These transactions come after the price had unexpectedly jumped to 1.159 RON/share on Friday. Of all the indexes, only the blue chips managed to post a hike and ROTX jumped 0.34% led by Erste Group Bank (+2.92%). In Europe, the results were mixed, with a clear split between developed markets and the rest. The former have generally seen uptakes. The news that a more dovish figure like Janet Yellen could take the place of Ben Bernanke later on has boosted support for equities yesterday. Today, however, the Fed's meeting starts and markets wait for an announcement of a reduction in stimulus. The crucial news may be the announcement of when exactly the QE will actually end which would prompt a rise in interest rates.

The leu and its peer currencies marked some gains yesterday. Currently, the EUR/RON is trading around 4.46.

Money market rates slid yesterday as we are approaching the end of the reserve period. The Central Bank did not inject any liquidity at the weekly repo. The 5Y CDS is 10 bps lower on a weekly basis.

The Treasury managed to sell RON 1bn in T-bills at an average accepted yield of 3.88%, lower by 27 bp than the previous similar tender in the beginning of August. The lower yield was in line with our expectations given the international context and the lower pressure to issue debt that the Treasury is facing after having sold EUR 1.5 bn Eurobonds last week. Demand at yesterday's auction was healthy, with bid to cover at 3.8X.
