**Summary**

- Advanced markets' leading indices ended with mixed results yesterday. Europe's key indices closed with modest gains, while US markets continued their losing streak.
- The dollar made small gains versus the euro yesterday; the EUR/USD is climbing toward 1.35 this morning.

The key indices of emerged markets closed with mixed results yesterday. Europe's key indices achieved small gains and even though American indices seemed to be able to reverse the several-day-long fall, they headed down at the end of trading and closed 0.0-0.4% in the red.

In Europe, the continued increase in Germany's IFO index added to the positive sentiment, whereas the Conference Board consumer confidence index in the USA dropped to 78.7 points, from 81.8.

Facebook's share price benefited from Citi's move to improve its recommendation to Buy and raise the target price from USD 32 to USD 55.

Yesterday the dollar slightly firmed to the euro on Tuesday. This morning the EUR/USD is rising toward the 1.35 line.
