**Summary**

- BET gained 0.5% yesterday in line with European equities; Janet Yellen's speech at her confirmation ahead of the Senate was in favour of more QE, thereby supporting riskier assets
- The leu gained 0.2% to the euro, boosted by Yellen's speech and to a lesser extent by the better than expected Q3 Romanian GDP data
- The Treasury sold 5Y bonds at 4.7%, 25 bps higher than in the end of October.

BVB indexes finished in the green yesterday, in line with the trend witnessed in Europe. Again, total equities' turnover was good, at EUR 18.6 mn and it was mostly made up by 4 stocks: Fondul Proprietatea, Romgaz, OMV Petrom and SC Transilvania Constructii. OMV Petrom took a hit this week and fell 6.7% on a weekly basis, of which 1.1% yesterday, after BERD sold its stake of 1.6% stake in Petrom. During her hearing in front of the Senate, Janet Yellen said that the accommodative policy will not last forever but she signaled that it will continue for the time being and that restricting bond buying too early could be dangerous. This supports risky assets and equities already opened in the green this morning.

The leu is stronger by 0.2% to the euro, boosted by the statement made by Yellen, while the better than expected Romanian GDP data had less impact. The EUR/RON is trading around 4.45 this morning.

The Treasury managed to sell the planned amount in RON 700 mn in 5Y bonds at an average accepted yield of 4.7%, which was 25 bps higher than what was recorded at the similar tender in the end of October. Bid to cover was modest at 1.66. The rise in yield is all the more important, considering that the Central Bank even cut the base rate by 25 bps on 5<sup>th</sup> November. On the secondary market, the yield curve continued to shift upwards on a weekly basis, between 2-11 bps. However, they could ease considering that fear of Fed starting to taper as early as December has been alleviated.
