Global Daily Report

Summary

- Global stock markets closed down amid trade war fears
- A number of countries, including EU member states, will be exempt from US aluminium and steel tariffs
- Bitcoin was hit, owing to fears about regulation
- Germany's IFO economic sentiment index fell to 11-month low

Worries about a possible trade war made equity indices sink on Thursday; stock markets were already volatile because of the Fed's rate decision on the previous day. The Dow slipped 2.9%, and the NASDAQ100 lost 2.4%. President Trump announced plans to impose USD 50 billion duty on a group of products imported from China. The White House's justification pointed out the lack of intellectual property rights, particularly in robotics, which is at the cutting edge of technological development. Before the new tariffs become final, there will be a 30-day comment period. China's government strongly criticized America's measure. Another report that added to market volatility was that Donald Trump's lead lawyer, in charge of the President's defence in the investigation into Russia interference in the 2016 election, had resigned. In trade-related news, EU member states, Argentina, Australia, Brazil and South Korea will be exempt from the steel and aluminium tariffs imposed by the USA.

Europe's stock exchanges also closed in the red, with the key benchmarks hitting three-week lows. The sentiment on this side of the Atlantic was also shaped by concerns about a trade war between the USA and China. The Bank of England left its key policy rate unchanged but its communication did not rush to dampen expectation of a rate increase in May.

The volatility on currency markets was also elevated. The US dollar appreciated against the euro. The EUR/GBP worked off the morning's slip by the close.

Bitcoin shrank 4.5% as Binance, the largest cryptocurrency transaction company, is in disagreement with Japan's regulator, which argues that Binance operates without a licence in Japan, and threatens with legal consequences.

The March reading of the IFO economic sentiment index was published yesterday. Amid angst that protectionism will advance, the indicator fell to an 11-month low. The purchasing managers' index also dropped from the February reading. In the USA, the February gauge of the US leading index was up 0.6%, topping analysts' predictions of 0.4% growth.

Today it is worth keeping an eye on the trade row between the USA and China. It did not take long for China to respond: this morning its Trade Ministry announced plans to impose USD 3 billion import duty on American products. The USA will also release important macrodata: the February US durable goods order and the new home sales statistics are due out. The US import tariffs on steel and aluminium imports take effect today.
