

Summary

- The ECB is likely to launch a comprehensive programme to loosen its monetary policy
- Yesterday's release of US corporate earnings figures disappointed
- Global stock markets had a gloomy day on Thursday
- The dollar depreciated against the key currencies
- Oil prices rose, while precious metals dropped

A mixed bag of data and reports came out on Thursday. While leaving its key policy rate unchanged, the ECB announced a comprehensive loosening programme, which may start in September, as inflation is stubbornly below target. The set of measures would include lowering deposit rates, re-launching the bond purchase programme, and a multi-tiered system for deposit rates, which would save banks from the adverse effect of the negative interest rate environment. Reasons include slowing growth, particularly in the ailing manufacturing sector, as well as the deteriorating inflation expectations, and the persistent weak inflation. The announcement triggered an initial euro weakening, but given that markets largely anticipated the measures announced, the single currency could even book gains against the US dollar at the end of the day.

The German IFO economic sentiment index was short of expectations. Conversely, US durable goods orders grew stronger than had been thought.

One of the main reasons for the lack of risk appetite on markets was that a number of important American companies published disappointing earnings figures. Owing to their worse-than-expected quarterly reports, the share price of Tesla nose-dived 13%, Ford reversed 7%, and Facebook fell 2%. Amid the resulting gloom on global stock markets, America's S&P500 dropped 0.5%, while the Nasdaq100 fell 1%.

In Europe, Germany's DAX lost 1.3%, France's CAC40 shed 0.3%, and Britain's FTSE100 closed 0.2% lower. The headwinds were felt in Central and Eastern Europe as well: Poland's WIG20 slipped 1.1%, while Hungary's BUX could edge higher.

Bond yields rose yesterday in many parts of the world, including the USA, Germany, and Europe's periphery countries.

Brent traded 0.3% higher. Meanwhile gold and silver lost 0.8% and 1.1% of their values, respectively.

The USA will release GDP data later today.
