Summary

- Global stock markets were rather quiet ahead of the Fed's two-day meeting that begins today.
- Stock prices were largely moved by reports of M&A deals.
- The GBP hit two-year low.
- This morning the Bank of Japan decided to leave interest rates at current ultra-low levels.

The benchmark indices of Europe and America closed mixed on Monday. The Stoxx Europe 600 ended nearly flat, the DAX edged 0.02% lower, and the CAC40 sank 0.2%. London's busy stock exchange grew dynamically throughout Monday; the FTSE advanced 1.8%, nearly hitting a 12-month high. In the corporate world, LSE's share price skyrocketed 15%, to an all-time high, following the announcement of ongoing talks to buy Refinitiv, a provider of financial data services. Also driven by news on mergers & acquisition, Just Eat Plc's stock price surged nearly 23%. Stock markets shrugged off the words of Boris Johnson, Britain's new Prime Minister, who said he would not start talks with the EU unless the block re-opens talks that were concluded during Theresa May's tenure. Fears that the UK might depart without a deal sent the GBP to its two-year low. The yield on the UK's 10Y bond dropped three basis points, and that on the German Bund inched one basis point lower in Monday's trading.

On the other side of the Atlantic, the Dow slipped 1.2%, the S&P edged 0.2% lower, and the Nasdaq100 lost 0.3% of its value. Nearly all tech giants sank into negative territory, with Facebook falling 1.9%, Amazon diving 1.7%, and Netflix shrinking 0.9%; only Apple could climb 0.9% higher, before publishing its earnings figure on Tuesday. Financial and communications service providers were the weakest performers, while defensive sectors (utilities, real property, and health care) were the strongest ones. In the latter group, share prices were driven by a possible merger of Pfizer and Mylan, a generic pharmaceutical maker; Mylan's share price jumped 12.6% higher, while Pfizer fell 3.8%. The US 10Y Treasury Note Yield dipped one basis point. Despite Monday's slight weakening, the US dollar is still at two-year high against the euro.

In America, the Fed's two-day meeting is likely to be in the centre of attention, as the FOMC is expected to lower interest rates by 25 basis points. Investors will probably also check the quarterly earnings reports of companies like Altria, Mastercard, and Merck, as well as the US employment report for July, due out on Friday.

In commodities, WTI and Brent advanced 1.2% and 0.4% respectively. Gold price grew by 0.5%. In industrial metals, zinc was up 1.3%, and copper added 0.9% on Monday.

Benefiting from the optimistic sentiment, Asia's benchmarks were in positive territory this morning. The Bank of Japan decided to leave interest rates at current ultra-low levels (-0.1%), and the target for the 10Y yield remained at 0%. The BoJ will not hesitate to ease monetary conditions if economic growth decelerates, central bankers warned.

Today France releases the first estimate on Q2 GDP, and the European Commission is to publish its latest economic sentiment index. Housing market statistics and consumer sentiment index will see the light of day in the USA.
