

Information and specific conditions related to money transfer service - MoneyGram

MoneyGram money transfer service is a service that allows sending / receiving money anywhere in the world, in few minutes, without the requirement of holding a current account at a bank or a card.

<u>Before using MoneyGram</u>, please note the following information and conditions, and explanations on the back of existing forms of sending / receiving money through MoneyGram:

- In order to make a correct sending / receiving money transfer through MoneyGram, we
 inform the obligation to complete correct with capital letters, of all information required in
 the receiving form, namely Receive Form, signing it and presenting your valid identity
 document in original.
- **Maximum execution time** that the payment service is available for the beneficiary is 10 minutes, according to information provided by MoneyGram International Limited.
- In case of a sending money operation, the total price you will have to pay for the money transfer is calculated by the formula PT = ST + CMG, where:

PT – Total price you have to pay for the transfer;

ST – The total amount you wish to reach the beneficiary;

CMG – the fee you have to pay for the transfer according with "Taxes and fees related to fast Money Gram transfers" displayed in the OTP Bank Romania SA territorial units and on the bank web-site <u>www.otpbank.ro</u>.

- In case of a receiving money operation, the beneficiary will not pay any tax amounts or cash withdrawal commission.
- **The effective exchange rate** which is going to be applicable to the sending operation is set by MoneyGram International Limited on the day of transfer. This will be provided at the

counter by the representative of the bank which operates MoneyGram transfers and it will be indicated on the form.

<u>Right after receiving the sending money order</u>, the Bank representative who make the transfer will provide you for verification and signature, before finalizing the operation, a printed confirmation document that will contain at least the following information:

- **The payment reference**, represented by the date and time printed on the confirmation document;
- The payment value in the used currency in the sending order.
- The total price you will have to pay for the money transfer is calculated by the formula PT = ST + CMG, where:
 - PT Total price you have to pay for the transfer;

ST - The total amount you wish to reach the beneficiary;

CMG – the fee you have to pay for the transfer according with "Taxes and fees related to fast Money Gram transfers" displayed in the OTP Bank Romania SA territorial units and on the bank web-site <u>www.otpbank.ro</u>.

- **The effective exchange rate** which is going to be applicable to the sending operation is set by MoneyGram International Limited on the day of transfer.
- **Receiving date** of the sending order.

<u>Right after the receiving money is complete</u>, the Bank representatives who made the transfer will provide you a copy of the receiving form, signed and stamped by the Bank, containing at least the following information:

- **The reference number** that allows the recipient and sender of the payment, identify the payment transaction and any information transferred with the payment;
- The payment value in currency in which funds were made available to beneficiary;
- The total price borne by the payer is calculated by the formula **PT = ST + CMG**, where: PT - Total price incurred by paying for the transfer;

ST - The total amount you received as a beneficiary;
